## GDPR Privacy Policy

### BACKGROUND:

AJK Woodflooring Ltd. understands that your privacy is important to you and that you care about how your personal data is used. **We** respect and value the privacy of everyone who visits this website, <http://ajk-woodflooring.co.uk> and will only collect and use personal data in ways that are described here, and in a way that is consistent with **our** obligations and your rights under the law.

Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of this Privacy Policy is deemed to occur upon your first use of our site. If you do not accept and agree with this Privacy Policy, you must stop using our Site immediately.

### 1. Definitions and Interpretation

### 3. **What Does This Policy Cover?**

This Privacy Policy applies only to your use of our Site. Our Site may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

### 4. **What is Personal Data?**

Personal data is defined by the General Data Protection Regulation (EU Regulation 2016/679) (the "GDPR") as 'any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier'.

Personal data is, in simpler terms, any information about you that enables you to be identified. Personal data covers obvious information such as your name and contact details, but it also covers less obvious information such as identification numbers, electronic location data, and other online identifiers.

### 5. **What Are My Rights?**

Under the GDPR, you have the following rights, which we will always work to uphold:

- g) The right to data portability. ## 7. **How Do You Use My Personal Data?**

Under the GDPR, we must always have a lawful basis for using personal data. This may be because the data is necessary for our performance of a contract with you, because you have consented to our use of your personal data, or because it is in our legitimate business interests to use it. Your personal data may be used for [one of] the following purposes:

- Providing and managing your Account;
- Providing and managing your access to our site;
- Personalising and tailoring your experience on our site;
- Supplying our products and/or services to you. Your personal details are required in order for us to enter into a contract with you.
- Personalising and tailoring our products and services to you.
- Communicating with you. This may include responding to emails or calls from you.
- Supplying you with information by email or post that you have opted-in to (you may unsubscribe or opt-out at any time by contacting us).
- Analysing your use of Our Site to enable us to continually improve our Site and your user experience.

## 8. **How Long Will You Keep My Personal Data?**

**We** will not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected.

## 9. **How and Where Do You Store or Transfer My Personal Data?**

**We** will only store or transfer your personal data in the UK. This means that it will be fully protected under the GDPR.

## 10. **Do You Share My Personal Data?**

**We** will not share any of your personal data with any third parties for any purposes, subject to one important exception.

In some limited circumstances, **we** may be legally required to share certain personal data, which might include yours, if **we are** involved in legal proceedings or complying with legal obligations, a court order, or the instructions of a government authority.

## 11. **How Can I Control My Personal Data?**

11.1 In addition to your rights under the GDPR, set out in Part 5, when you submit personal data via **our** Site, you may be given options to restrict **our** use of your personal data. In particular, **we** aim to give you strong controls on use of your data for direct marketing purposes (including the ability to opt-out of receiving emails from **us** which you may do by unsubscribing using the links provided in **our** emails.
